

Police Commissionerate, Bhubaneswar-Cuttack has launched a special drive called, "DADABATIKU NA" against extortion. The problem of extortion is multifaceted. We are acutely aware of possibilities that Industries, Businesses and Individuals may avoid reporting about extortion demands fearing retaliation, apprehending project delays or because they may not be sure about possible remedies within the criminal justice system. The attitude of normalising extortion has to be fought by effective messaging to victims of such crimes supported by stringent and visible police action.

2. A set of stakeholders consultations are being planned. We will be happy to partner with various agencies and bodies in your domain to understand any such harassment faced by business and to proactively confront the issues. A dedicated helpline number has been launched, which is 9938910000, for secured communication with the team at Commissionerate Hdgrs. A task-force has been constituted under Ms. Rekha Lohani, Additional Commissioner of Police with relevant officers in the task-force. This team meets once every 15 days to take stock of the situation in the twin city. We have already registered more than 50 cases within a short time of 20 days and arrested about 80 persons. This drive has to be sustained over a period of 2-3 years for lasting

offenders may include in such crimes to support ostentatious life-style. There is a need to be alert to the possibility that even the e-tender system can be gamed because the bidder universe becomes predictable.
